<u>High School Update</u>: Richmond Varsity Cheer took 2nd at States on Saturday, March 5th. Congratulations to Richmond wrestler, senior Aaron Kilburn, for placing first in the 125 pound weight class of the Division 3 individual state championships on Saturday. Kilburn is a fourtime state placer. Other wrestlers earning All-State honors include sophomore Colton McKiernan, who placed 3rd at 171; junior Roy Costello, who placed 4th at 112; sophomore Alex Roberts, who placed 4th at 140; senior Graham Barton, who placed 6th at 135; and senior Cody Keller, who placed 7th at 119. The Mock Trial performed well at its recent event. The National Honor Society induction will take place on Tuesday, March 15th. The band went to Festival last week and received a division 1 rating. Congratulations to the Robotics Team for winning the Judges Award and placing 5th at the Kettering First Robotics Competition.

School Update:

Legislative Update:

Detroit Public School Reform Plans continue. The third grade reading bill is resurfacing. House Bill 4822 as passed by the House in October, requires that beginning in the 2019-2020 school year, a third grade student's promotion to grade four be based on reading proficiency (with retention a onetime event). Stay tuned in to the upcoming State budget hearings as the budget allocations will affect solutions to the Detroit Public School's deficit.

10. PRESENTATIONS

- A. <u>2016 17 Budget Presentation –</u> The Budget Discussions will continue over the next several weeks until the next budget approval which will take place on June 27th, 2016. Mr. Walmsley gave an overview of the function codes and a brief explanation of the budget as well as providing next school year projected enrollment numbers and projected revenues.
- B. <u>Request for Overnight Trip to Washington D.C.</u> Dr. Ladd requested approval for his 7th Washington D. C. overnight trip with his Mock Trial group. He makes the trip every other year. It is self-funded mainly by the parents. He currently has 20 students and 12 parents signed up. Board action will take place at the March 28th regular meeting.
- C. <u>Michigan State High School Clay Target League –</u> Several students have shown interest in forming a Clay Target League. They must have a valid hunting license to join and practices will be held at the Richmond Sportsmen Club. The cost will be \$250.00 per student. It will be self-funded and there is no affiliation with the MHSAA.
