9. BOARD OF EDUCATION STUDENT REPRESENTATIVE REPORT: Haley Fortuna Elementary School Update: March is Reading Month has ended and the students logged 132,000 minutes. That means that Ms. Borwick will get pie in her face and Mr. Mangune will have eggs broken on his head.

10. SUPERINTENDENT AND LEGISLATIVE UPDATE

School Update:

- SAT testing takes place tomorrow for the Juniors
- The DTE planned power outages in Richmond last Monday and today have caused us some inconveniences.

Legislative Update:

- The Legislature is returning from its two week Spring Break. Budgets will be the priority over the next few weeks.
- Before the break the Senate passed their Detroit Public School Reform legislation. The bills head to the House for consideration but face an uncertain future as the House appropriations Committee continues to work on their version of DPS reform.
- The third grade reading bill 4822 was able to pass the Senate, but the House refused to concur with the Senate's changes. The bill will head to conference where both the House and Senate will work toward more compromising language.

There will be plenty of art, music and food for all.

Margaret Teltow – Announced that it was Assistant Principal's week and thanked Ms. Borwick and Mr. Bourdeau for their dedication.

12. PRESENTATIONS

- A. Request for Overnight Trip to Florida Stacy Neumann and Molly Schack requested approval for the 2016-17 trip to Florida to visit Disney and Epcot for band and choir workshops. The departure date is April 27, 2017 to April 30, 2017. It is open to band and choir students in grades 9-12. Action will take place at the next board meeting on April 25, 2016.
- B. <u>Creative Curriculum Presentation</u> Mr. Birkmeier, Curriculum Director, Mr. Mangune, Lee Elementary Principal, Lindsey McCoy, GSRP Teacher, Laura Ottenbacher, GSRP Teacher and Katie Bruyneel, Early Childhood Center Director and Three year old Preschool Teacher, presented information on Creative Curriculum. Creative Curriculum is supported by the MISD, research based and brings consistency among all Preschool Programs. It is a balancing act of learning through play.
- C. <u>MISD Budget Presentation</u> Member Kyle Simmons gave an overview of the MISD Budget Presentation that he attended at the MISD Keith Bovenschen School on March 31, 2016. He said that the MISD's funding comes from property taxes and they are currently at a deficit. Since they saved money from the past they are able to use money from the general fund and are able to maintain the same level of services.
