11. PRESENTATIONS

A. Freshmen Sports 2015-16

Mr. John Bourdeau, Dean of Students at the High School presented the final 2015-16 Freshmen Sports report.

They began with a rolled balance of \$11,346.38 and ended with a balance of \$7,570.03 which is enough to fund freshmen sports for the 2016-17 school year.

B. K-12 Science Curriculum Review

Anthony Birkmeier, Director of Curriculum, presented the new Michigan Science Standards. In November of 2015 the State Board of Education adopted new standards for science based upon the Next Generation Science Standards. The new standards replaced those that were adopted in 2006. The new standards represent a shift from a broad array of content to a focused integration of science practices and concepts. Mr. Birkmeier presented a course description for each grade level.

C. <u>Regular School Election Resolution – Millage Renewal</u>

Vicki Laseke, Business Manager, explained the Operating Millage Renewal Proposal. This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance and renew millage what will expire with the 2017 tax levy. This is a renewal and will be on the November ballot for Richmond Community Schools.

D. Early Warning Legislation

Vicki Laseke, Business Manager, also explained the Early Warning Legislation with a slide presentation. Early Warning Legislation is an overview of options and possible consequences for School Districts who are under fiscal stress. Treasury is looking at Fiscal year 2013 and 2014 for districts that have fallen below the 5% fund balance. Fund balance is the accounting term for the difference between total assets and total liabilities. They also look at late payments, missed payroll, audit or budget violations and can use their own determination. Once a district is determined to be a potential for fiscal stress, a notice is given to the district and it has sixty days to enter into a contract with the ISD for administrative review. The ISD must make a recommendation within ninety days.

E. Budget

Lengthy discussion was had in order to finalize the 2016-17 budget. The budget hearing is scheduled for June 27, 2016. Several line items were discussed and reviewed. Superintendent Walmsley was asked to make some final adjustments before presenting it at the June 27th Budget Hearing.
