Legislative Update:

- One of the controversial bills that is back before the Senate Education is Senate Bill 826 which would repeal Michigan's career and college ready standards, prohibit the use of an aligned assessment, and limit the state's future standards setting authority. Michigan's current standards would be replaced with Massachusetts 2009 standards.
- May 2nd the House and Senate will begin building the budget for the upcoming fiscal year.
