8. PRESENTATIONS

- A. Richmond Baseball Initiative (RBI) Scoreboard Donation Mr. Scott Evans explained that the Richmond Baseball Initiative (RBI) Organization would like approval to replace the existing scoreboard on the baseball field. The current scoreboard, in memory of Chuck Spezia, is broken and is not repairable. Mr. Pat McCloskey, who is a member of the International Brotherhood of Electrical Workers stated that their union association is working with schools to help put in scoreboards and may be willing to fund the purchase of a new one. RBI is requesting approval to purchase a scoreboard at no cost to the school district. The purchase will either be made with the help of the IBEW or fundraising. He was told that the action item will more than likely be placed on the January agenda.
- B. Freshman Sports Update The District General Fund does not fund freshman athletics so a report is periodically reviewed to make sure there are enough funds. Mr. John Bourdeau, High School Dean of Students presented the 2015 Fall Athletics preview. Football won the 2015 District Championship and was 2015 Regional Runner-Up. Cross Country and Volleyball also did well, and Boys Soccer won the BWAC Championship, District Championship and Regional Finalist. According to the Freshman Sports Balance sheet there will be enough money to continue to fund the current school year and the 2016-17 school year.
- C. <u>Phase Two of Bond Project</u> A list was presented of the currently approved bond items that will be part of phase two and a list of things that are still needed by the buildings. Mr. Walmsley expressed that two of the district's main priorities are the copiers (an action item on the agenda) and the Heating and Cooling System, switching the Honeywell system to Metro Controls.
- D. <u>Print Solution Update</u> Information was provided regarding the printers. A recent request for proposal was issued. After an analysis of the bids received, it was determined that Millennium Business Solutions would be the vendor recommended to purchase copiers for the District's print solution.
- E. Revised Civil Rights Compliance Plan During previous board meetings there was discussion about possibly closing the Boys Varsity Basketball Locker Room and or converting it to a Wrestling/Cheerleading room since the sports are not gender specific and the room was not in compliance with the Americans with Disabilities Act. However, since then, logistical concerns as well as concerns from the Michigan Department of Education which oversees the compliance plan has resulted in the need to revise the plan. The Athletic Boosters have a committee to pay 100% of the renovations, but other compliance issues are estimated at around \$10,000.00 and would be charged to the Bond or General Fund accounts.

Before the holiday break, there may be a decision made as to whether Detroit Public Schools will be helped with state aid money.

She said it was excellent and thanked Mr. Finlay, the music director. She also stated that a Student Board Representative will be joining us in January. Her name is Haley Fortuna and she is sophomore.
