B. Staff Culture Survey Follow-up

9. PUBLIC COMMENT

The following members of the public spoke:

- D. Michon stated that she received one 91) email regarding the health departments requirements and mandates, which Superintendent Walmsley addressed.
- Jill Manchik spoke of students access to mental health services, \$1.4 billion (\$4.5 million) invested in local health departments, soon-to-be approve vaccines for children, and the federal governments campaign to vaccinate children.
- Jill Manchik time expired and another parent (not known) yielded her time for Ms. Mancik to finish.
- Amy Stier read a prepared statement by Danielle Hall regarding the District's amendment to the 2021-22 Return to Learning Plan is discriminatory and divisive. Referenced several studies to support statements. Furthermore, Ms. Hall requested any communication between Mr. Walmsley ad the District's attorney regarding requirements to quarantine.
- Kelly Oldani stated that she no longer believes the MDS is protecting our students. BAMN (By Any Means Necessary) is a grassroots parent groups that will stand up against any group, including school boards, to protect students from government over-reach, including funding, Critical Race Theory (CRT), Sex Education, and *Every Student Succeeds Act*.

10. SUPERINTENDENT AND LEGISLATIVE UPDATE

B. Walmsley

Superintendent Walmsley provided the following update:

Curriculum, Instruction and Assessment Report as received from Renee Ara, Executive Director of Curriculum and Educational Services

Curriculum – As part of the state transition to Perkins V, all CTE CIP codes will be going through an alignment process that moves them from segments to competencies. During this transition/alignment process credentials will also be identified and a requirement for all CTE courses. Ms. Ara and Mr. Burg have begun working on the Business curriculum alignment and certification process.

Data and Assessment – Requirements for 2021-22 Educational Goals for K – 12

- Each school building has established their educational goals by September 15, 2021. These goals were NOT submitted anywhere. Each school is required to have them on file.
- The goal accomplishments will be publicly reported at the first board meeting in February and then again before the last day of school. The goal accomplishments will also be shared through the district's website in February and then again before the last day of school.
- By law the data is required to be disaggregated by grade level, student demographics and mode of instruction (such as in-person or virtual).

Overall Parent-Teacher Conferences went well. Superintendent Walmsley asked Ms. Ara to collect from the buildings a break-down of the number of parents/guardians electing for virtual conferences vs. in-person conferences. This will assist us in planning future parent-teacher conference events.

Richmond Middle School

- Student council Election will be coming up, no date was provided by the MS team.

Will L. Lee Elementary School

- Mrs. Mangune, Mr. Gibson and the Title I staff are currently identifying students that are eligible for Title I services to begin targeting interventions.
- NWEA testing is completed at the elementary school.
- Grade level data dives are beginning next week (utilizing the new data protocol from Ms. Ara, which will be shared with eh Board at a future meeting.
- Individual Reading Intervention Plans (IRIP) have begun for eligible students
- The administrative team and Title I staff, along with Ms. Ara are planning for upcoming Title One Family Engagement events. Stay tuned.
- Halloween Parade and Trunk-or-Treat are scheduled for this Friday, October 29, 2021. I believe the Board will have a "Trunk" at this event.
- Mrs. Mangune and Mr. Gibson are conducting ongoing daily walk-throughs in teacher classrooms to observe instruction, as required for the completion of evaluations.

Legislative Update

Legislature Slams Through Voucher Bills; Contact Your Legislators Today

On Tuesday [October 19th], both the Senate and the House passed bills to establish "student opportunity scholarships." These scholarships are the latest attempt to create vouchers in Michigan, something that is strictly prohibited by our State Constitution. <u>Senate Bills 687-688</u> were approved by the Senate Education and Career Readiness Committee first thing in the morning and passed the full Senate by a vote of 20-16, just a couple hours later. <u>House Bills 5404-5405</u> were approved by the House Education Committee about an hour after the Senate committee met and were the first bills brought up for a vote later that afternoon, passing by a vote of 55-48.

The bills, which appear to be identical in each chamber, would establish scholarships for certain students that would be administered through a scholarship granting organization (SGO) that is defined in the bills. It could be used for private school tuition or fees, summer programs or

Any money donated to an SGO would be allowed to be deducted from a person or entity's income taxes. The program is estimated to cost more than \$500 million in income tax deductions, thereby reducing School Aid Fund and General Fund revenues. This amounts to indirect aid to nonpublic schools, which is specifically prohibited by Michigan's Constitution.

We are watching this closely as it ultimately will impact school budgets of all public schools., including Richmond.

Legislation on Post-Secondary Information Reaches House Floor

On Tuesday, the House Education Committee unanimously passed <u>House Bill 4953</u>. which would require the Michigan Department of Education to develop and update information on postsecondary education for 8-12th grade students by Aug. 1 of each year. These informational packets must include:

- average tuition costs.
- average amount of student loans incurred.
- graduation rates; and
- the most in-demand occupations in the state along with other criteria.

MDE must distribute this information to all districts, Intermediate school districts, and publicschool academies and make it available via their website. Districts would have to share with their students but would have the flexibility to decide how best to do that.

This is good legislation which will give students and parents information on postsecondary institutions.

Finally, Superintendent Walmsley read a prepared statement regarding the current working condition between the Board and Superintendent.
