Legislative Update:

School Aid Supplemental Passes the Senate

On Wednesday, January 18, 2023, the full Senate quickly passed supplemental budgets for the School Aid Fund and the General Fund by party-line votes. The bills make appropriations for last fiscal year and this one, adjusting amounts previously appropriated. Senate Bill 8, the School Aid Fund budget, includes language that would allow MPSERS supplemental payments to be made on behalf of all participating entities (including ISDs), not just local districts. The bill also adjusts amounts needed for special education reimbursements and school breakfast. Finally, it adds \$27.9 million in federal dollars for the state to establish safe and healthy learning environments.

The passage of these two bills also moves forward closing the books with final numbers for the 2021-2022 fiscal year. This was not completed before the end of last session. The bills are now under consideration by the House Appropriations Committee. We expect the House to act on them next week.

Bond Update
