DISTRICT UPDATE:

This morning, each of the building administrators and I had the pleasure of visiting the classrooms of this year's Teacher-of-the-Year winners. Elementary Teacher-of-the-Year is Ashley Gibson, Middle School Teacher-of-the-Year is Kristie Cramton, and High School Teacher-of-the-Year is Joseph Ogilvy. These individual will now go on to represent Richmond Community Schools at the Macomb County Teacher-of-the-Year celebration and competition and will be invited to a Board meeting to be recognized in the spring.

Special thank you to the individual, who wished to remain anonymously, that came in to the Board Office on Tuesday, February 4, 2020 and wrote a check to pay every the negative lunch balances for all students. This individual wrote a check for \$5,960.81. This generous donation helped hundreds of families, who do

not qualify for free or reduced lunch, and were struggling paying their lunch debt. On behalf of the Richmond students and families, thank you.

Legislative Update:

On Thursday, February 6, 2020, the Executive Office delivered Gov. Whitmer's Executive Budget Recommendation for FY 2021. The budget reflects the governor's priorities, improving education and skills for Michigan's children, protecting our families and public health, and cleaning up Michigan's water and fighting climate change.

Overall, the budget totals \$61.9 billion, which reflects a 3.9% increase from the current fiscal year. The General Fund/General Purpose budget has increased by 5.8% to a total of \$11 billion, which reflects baseline increases and one-time investments.

On the School Aid front, the budget for FY 2021 is \$15.9 billion, a 4.9% increase over the FY 2020 budget.

Community colleges remain fully funded with School Aid Fund dollars. For FY 2021, the executive budget recommendation includes total funding of \$433.8 million SAF, an approximate 2.5% increase. Higher Education continues to share School Aid \$400,000,000 money as well; however, their 2.5% increase comes at the expense of the General Fund.

The governor's proposal continues the movement toward a weighted funding formula and provides \$415 million for this goal. This equates to a \$290 million increase base per-pupil funding distributed through a 1.5X. The minimum funding allowance will increase to \$8,336 and \$8,679 for districts at the maximum. This equals a \$150-\$225 per pupil increase and reduces the gap between the highest and lowest funded districts to \$343 per pupil.

The executive budget increases the Great Start Readiness Program section by \$35.5 million to boost the state payment for a full-day preschooler from \$7,250 to \$8,336. Further, the proposal includes \$42 million to expand access to preschool for children living in high-poverty districts.

A new section in the governor's Executive Recommendation provides \$25 million to reimburse teachers up to \$250 for out of pocket supply costs through a teacher supply reimbursement and purchasing program.

Other highlights in the School Aid Budget:

- \$5 million for CTE incentive payments is maintained
- Sec. 81 operation funding for intermediate school districts is increased by 3%, to a total of \$71.2 million
- \$205.9 million for MPSERS obligations to reflect changes in assumptions for the longer lifespans for retirees

- This increase in funding reflects an increase in services to 5,000 children
- Maintains \$31.5 million for state-funded literacy coaches
- Increases state funding for literacy essentials training by \$3 million
- \$40 million for one-time grants to support districts with air and water filter replacement, lead and asbestos abatement, heating and cooling modifications, building modifications, and other facility upgrades to provide students with safe, healthy learning environments
- \$1 million to offset district costs of forgiving existing student meal debt

The budget includes \$1.5 million to expand existing and create new teacher cadet programs to help create a student-to-teacher pipeline for high school students, while helping to keep our educated youth at home where they can grow to become advocates for their schools and communities.
