B. State/Federal Level

- a. Rep. Lee Chatfield (R-Levering) was elected as Speaker of the House, Rep. Triston Cole (R-Mancelona) was chosen as Majority Floor Leader and Rep. Jason Wentworth (R-Farwell) as Speaker Pro-Tempore. For the Democrats, Rep. Christine Greig (D-Farmington Hills) was chosen as Minority Leader and Rep. Yousef Rabhi (D-Ann Arbor) as Minority Floor Leader.
- b. Sen. Mike Shirkey (R-Clarklake) was chosen as the Majority Leader, Sen. Peter MacGregor (R-Rockford) as Majority Floor Leader and Sen. Aric Nesbitt (R-Lawton) as President Pro-Tempore. Lt. Governor Garlin Gilchrist serves as the President of the Senate, but only casts a vote in the case of a tie.
- c. The numbers for the 2019 and 2020 fiscal years were increased from the May 2018 estimates for the General Fund, but were adjusted down by almost \$24 million for the School Aid Fund.
- d. We expect Gov. Gretchen Whitmer's upcoming State of the State address, followed by her budget presentation in February, to shed more light on her plan for Michigan as she begins her administration. The State of the State will be held on Feb. 5.
- e. Just three days into the new Attorney General's tenure, and four days after House Bill 5526 was signed into law, the Michigan Department of Education asked AG Dana Nessel to review the new A-F letter grading system that was passed by the Legislature during lame duck. Citing concerns that the new system may violate federal law, MDE asked Nessel for a legal review of the policy.
