C. State/Federal Level

- 1. House Education Committee Begins Hearings on ACT WorkKeys Requirement
 The House Education Committee began hearings on House Bill 4162, which would eliminate the
 requirement that districts include the ACT WorkKeys assessment in the Michigan Merit
 Examination. It would allow a district to continue to use the test if it sees fit.
- 2. Senate Finance Considers Fix Sales Tax Exemption Bill The Senate Finance Committee took testimony on <u>Senate Bills 43 and 44</u>, which would exempt contact lenses from sales and use taxes, thereby reducing revenues to the School Aid Fund. MASB testified in opposition to the bills as one more cut to the revenue streams for schools. We point out that last session, eight laws were signed that diverted at least \$195 million from the SAF and 13 other laws will have an indeterminate negative cost. This equates to more than \$130 per pupil.

As before, we stated that it is not necessarily the merits of the policy we oppose but the continued erosion of revenue streams to support our schools. There were some on the committee who expressed similar concerns. A vote was not held, but we do expect further hearings.
