B. <u>Donation for Athletic Field Improvements</u>

John Foster from Foster Oil approached Chris Rinehart, High School Dean of Students, about donating a concrete foundation for bleachers around the Girls Varsity Softball field. He then agreed to donate the concrete foundation for both the Varsity Boys and Girls fields. This donation will ensure the District meets Title IX compliance for comparable facilities for boys and girls sports.

C. <u>Fiscal Year Budget Presentation #3</u>

Superintendent Brian Walmsley provided the Fiscal Year 2019 Budget Presentation #3. He reminded the board that they had agreed upon basing the budget foundation on the \$230.00 per pupil increase based on the Senate budget. He reviewed the projected enrollment and provided participation numbers from the past two years for freshmen sports. A suggestion was made that freshmen sports be funded approximately \$8000.00 next school year with the assumption that efforts would be made throughout that year with fund raising to cover the costs the following year. The board will then reconsider freshmen sports for the 2019-2020 school year. Declining projected allocations for Title Funds were also discussed.

D. Bond Projects – Phase Three
