- B. <u>Lunch Prices</u> Sue Bevins provided a PowerPoint presentation to explain the increase in lunch prices for the 2016-17 school year. If the district increases lunch prices from \$2.50 to \$2.75 at Lee and does not increase prices at the middle school (\$2.75) and high school (\$3.00), it would generate an average price of \$2.83 which will provide a positive carryover to 2017/18 of 5 cents, thus likely to not require an increase in 2017/18.
- C. <u>K-12 Theatre Program</u> Kelly Osterman was available to provide an overview of the theatre program and provided a proposed contract in which the Youth Theatre would provide a complete performing arts program meeting all State of Michigan Educational Standards to the Richmond Community School District for the 2016-17 school year. All programs would be for Richmond students only. The program will include complete coordination including scripts, rights, costumes, sets and tech from auditions through performances. It was concluded that this may require further discussion.

D. <u>2016 – 17 Budget Presentation</u> Superintendent, Mr. Brian Walmsley, reviewed the proposed budget by presenting a Revenue spreadsheet and a complete expense spreadsheet. He reviewed several line items on the expense sheet.
