Richmond Community Schools is approximately 71 square miles and includes the City of Richmond and Townships of Casco, Columbus, Lenox, and Richmond, in Macomb and St. Clair Counties.

MEMBERSHIP

The seven members of the Board of Education are elected from the district at large to serve six-year terms. Terms are staggered.

To be eligible for election to the Board, a person must be a qualified voter and reside in the district. Terms of office and election of officers commence at the first meeting in January.

BOARD MEETINGS

The Board of Education meets regularly on the second and fourth Monday of every month at 7:00pm in the Media Center at Richmond High School, unless otherwise indicated.

From time to time the Board may schedule other special meetings if there is need. Board of Education meetings are always held in public with agendas made available at meetings.

In general, the first meeting of the month is designed for presentations and the second meeting of the month is designed to vote on action items.

Did You Know? Board policies are located on the district's website, under the School Board link, located on the left side of the website.

PUBLIC COMMENT

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on district matters.

To permit fair and orderly public expression, the Board shall provide a period of *Public Comment* at every meeting of the Board, allowing 3-minutes of participation for each individual. Board policy governing such participation is available at each Board meeting and on the website.

The presiding officer at each Board meeting, at which *Public Comment* is permitted, shall administer the rules of the Board for *Public Comment*.

The presiding officer at each Board meeting shall be guided by the following rules:

- Public comment shall be permitted as indicated on the order of business of this Board and at the discretion of the presiding officer or other members of the Board, as required by the Michigan Open Meetings Act.
- Anyone having legitimate interest in the actions of the Board may speak during the *Public Comment* portion of the meeting.

Participants must be recognized by the presiding officer and must preface their comments by stating their name and district affiliation.

Participants shall direct all comments to the Board and not to staff or other participants.
