At Home



Parents/guardians are expected to conduct [DAILY HEALTH SCREENING](#) for the following symptoms:

Fever | Fatigue | Body Aches | New or worsening cough
Congestion | Sore Throat | Loss of taste or smell | Headache
Shortness of breath | Nausea | Diarrhea

DO NOT SEND YOUR CHILD TO SCHOOL WITH A TEMPERATURE OVER 100.4°

Getting to School

... by Bus



Students age 12 and under are required to have an adult at the bus stop.

Prior to getting on the bus:

- Health Screening Self-assessment
- Temperature check
- Use of hand sanitizer
- Mask must be worn
- Weather permitting, bus windows open

... by Car



- Drop off only. Buildings will open for students at the following times: HS* and MS at 7:30am and ES 7:40am. Students arriving earlier will be required to wait outside using appropriate social distancing. (* with exception of Zero hour).
- Parents and guardians who walk their child to the building, must PARK in a designated parking spot.
- Parents and guardians waiting with students are expected to follow and model social distancing requirements.
- Non-district employees are NOT allowed in the building.

... by Walking



- Drop off only. Buildings will open for students at the following times: HS* and MS at 7:30am and ES 7:40am. Students arriving earlier will be required to wait outside using appropriate social distancing. (* with exception of Zero hour).
- Parents and guardians waiting with students are expected to follow and model social distancing requirements.
- Non-district employees are NOT allowed in the building.

At School

Before entering the building, students will have their temperature checked, complete a self-assessment health screening questionnaire, and use hand sanitizer.



... in the Classroom

- All Staff required to wear facial coverings (e.g. mask or shields).
- Desks spaced for maximum social distancing as allowed by room.
- In-person student images may be captured by learning livestream cameras for virtual students.
- Facial coverings (e.g. mask or shields) are required to be worn by Grades 6 - 12 students at all times. Optional for PreK-5 students in the classroom.



... in the Lunchroom

- Lunch tables spaced for maximum social distancing as allowed by space.
- Approx. 2-3 students per lunch bench.
- Attempt to stand 6 feet apart while waiting in the lunch line.
- Facial coverings (e.g. mask or shields) required to be worn to and from the lunchroom, but not while eating.



... in Hallways and Common Areas

- Facial coverings (e.g. mask or shields) required to be worn by ALL students and staff.
- Attempt to maintain 6 feet between students while walking in hallways.
- Stay to the right of the floor tape in the hallways, one-way hallway traffic
- Common area drinking fountains turned off, students are encouraged to bring water bottles to school.

Additional Cleaning Precautions

Additional custodians during the day | Disinfecting of common areas scheduled multiple times per day

Playground equipment disinfected multiple times per day | Classrooms cleaned during teachers prep hours and disinfected daily
