Under Section 10A of the Michigan Freedom of Information Act, you have a right to appeal a fee that you believe exceeds the amount permitted under the District's written Procedures and Guidelines or Section 4 of the Act. You may submit a written appeal to the Superintendent for a fee reduction or waiver that specifically states the word "appeal" and identifies how the fee exceeds the permitted amount. If you do not receive a response within 10 business days or your appeal is denied, you may then commence an action in the Macomb County Circuit Court for a fee reduction within 45 days. If you commence a civil action, the District is not obligated to complete processing the request until the court resolves the fee dispute. If you prevail by receiving a reduction of 50% or more of the total fee, the court may award you an appropriate portion of reasonable attorneys' fees, costs, and disbursements, as well as damages if the District arbitrarily and capriciously violated the Act.
